Deputy Mayor Joy- I believe this budget continues to provide for improved service to our residents with planning for new opportunities and economic growth.

Maintaining existing mil rate levels and service fees shows good financial management while keeping a very low debt ratio at 8.4 %. This speaks well.

A few items that I particularly like.

- Includes for increased funding to our seniors group for operating programs and travel to events.
- Increased amounts for seniors discounts receiving the Guaranteed Income Supplement. We have to work toward discounts for low income families.
- Funding our fire equipment.-This is a priority issue as we continue to look at fire protection for residents. Volunteer fire men have provided fire protection in our town for a very long time and they are to be applauded for their service. They are a committed group who have given freely of their time and in turn have saved us a boodle of money for fire protection. We are now at a different point in time. Unfortunately due to a lower # of volunteers and present members work schedules we find ourselves particularly in day time with not been able to have adequate #'s to respond to fires. This is very concerning. The only answer to fire protection is a regional arrangement and towns in C.B.C. should agree to start work on this which would secure fire protection for the long term.
- Use of our gas tax for improvements of local roads and paving of gravel roads. This will result in cost savings of class A material, equipment and manpower and will improve service to residents.
- Cost sharing for capital projects such as north arm water line, gravel roads, MYCW, 2.2 million.
- New equipment for public works such as the recently purchased 3/4 ton truck for sanding and plowing our roads. Also purchase of suitable equipment for brush clearing with plans for ditching, replacing culverts, etc.
- Provision for safety related items such as speed bumps to reduce speeding,improvements to walking trails and replacing sections of boardwalk.
- Provision for purchase of park benches, tables, etc. in recognition of residents or families who have contributed to our town.
- Continued funding of community groups that support our residents > sea cadets, Healthy lifestyle, ground search and rescue,etc.
- Amounts for equipment in conjunction with our new emergency preparedness plan.
- We have made marked improvements in recreation in last few years and this year we will complete the playground on ridge road north

- arm. Also design of C.B.C. Regional Healthy Lifestyle & Leisure Center Facility.
- Focus on maintaining a clean town and addressing properties that are not been maintained at a reasonable level.

So these are some of the positives in this year's budget. There are a # of others

I would like to thank Gary and staff for all the work in preparing this budget. They have done an excellent job in providing good detail of expenditures and revenue.

Councillor Penney- 5 or 6 years ago we hired a consultant to advise council where to go in the future (Strategic Plan). We have hired CAO, Recreation, ED, Public Works Director, OHI Director, appointed Marie as Director of Finance, and Christa as EA. The revenue in this town has almost doubled. We as council are seeing the results. We have an excellent management team, with great vision. We as council sat in on many meetings during the budget, but the vision came from the people who work in the office. Thanks to all our staff and we are fortunate to have them. Makes our job as councillor much easier. The community of Holyrood is well on it's way in preparing for the future, and we are a community on the move.

Mayor Goobie- Councillor Penney hit the nail on the head. Several years ago we had a lot of demands on budget, and struggled to get a balanced budget. We brought in the best consultant, John Walsh, and spent two days developing the strategic plan. We have been following that plan ever since. In order to get things structured and organized, we needed the right people hired to do this. We are finally realizing how everything is coming together, and we have control of our destiny. Last year we had to increase taxes to operate in an efficient manner. The whole winter last year, I only received one comment on our snow clearing. Public Works have come a long ways in improvements in snow clearing, water, etc. Things are going the way we want them to go. I commend staff and council in preparing this budget. This budget is very visionary.

Ghaney- incredible work done by staff and council. Very solid budget and I am happy with it.

#### 8. NEW BUSINESS

**Deputy Mayor Joy-** a few weeks ago I attended tree lighting at Bowring Park. We have a beautiful park at Holy Cross Park that compares to Bowring Park. We should take into consideration of this location for our tree lighting next year.

Another year has gone, and I want to say it was a pleasure to work with all during the year. Look forward to the New Year, and wish everyone a Merry Christmas.

**Councillor King-** I would like to commend Marjorie and Council for securing funds for the Library. Spectacular work happening there. Great to see the improvements. Expected to be completed the end of February.

**Councillor Ghaney-** I would like to wish everyone a Merry Christmas. It's been a good year. I have learned a lot from everyone. Look forward to the New Year.

**Councillor Myette-** I would like to congratulate everyone on the budget. Thank you town staff and councillors for supporting me as a councilor over the past year. Look forward to 2015 and to see what Steve has in store in recreation. Wish all residents a Merry Christmas and a Happy New Year.
