## 7. INFRASTRUCTURE AND PUBLIC WORKS

- b. BE IT RESOLVED the Town of Holyrood requests an amendment to the Sewer Upgrades Project 17-GI-22-00037. The engineering and design of this project has identified a more intense scope of work which would see a upgraded wastewater treatment plant, disinfection system, lift station, oxidation ditch and pump station. The original cost was 1million four hundred thousand fifty dollars but given the required work to do the job in its entirety instead od creating delays through phasing, the complete cost is 2million two hundred seventy-eight thousand, nine hundred thirty-seven dollars and 72 cents. This adds an additional 799,583.72 to the project.

**Preamble**: the overrun of the project means we do the entire work to meet the federal guidelines for sewer and we do it without completing the work in phases creating the potential for additional delays and problems with sewer treatment. There is an opportunity for the town to request these additional funds under the present ICIP finding. The cost for the town would be 10% - **totaling 79,958.37**. This is a small amount to bring sewer treatment to where it needs to be to ensure the Town is following federal regulations and to ensure we are providing safe, reliable services to residents using that

- service. The Town of Holyrood can borrow this money under its present fiscal condition.
- c. BE IT RESOLVED the Town of Holyrood request a time extension for its Sewer Upgrades project 17-GI-22-00037 to allow time for completion of design and scope changes as experienced in preparation of the startup of the project. We are requesting that the project end date be changed from August 2025 to August 2026 to ensure completion in its entirety.
- d. BE IT RESOLVED the Town of Holyrood submit a gas tax application to complete improvements to the water and sewer infrastructure at Kielly's Lane. The Town requested bids to replace the existing infrastructure with new water and sewer lines to comply with current government standards and to reduce the continuous water leaks in the area. Total cost of the of the project is 63,850.00 HST included as submitted by the lowest bidder Buckles Contracting.

BE IT RESOLVED the Town of Holyrood accepts the revised Schedule A (2017-2020) identifying the reallocation of funds to the existing MYCW allocation which has been approved by the Department of Transportation & Infrastructure in the March 15, 2024, notification of approval letter. Schedule A identifies six approved projects through the multi-year program
- c. **BE IT RESOLVED** the Town of Holyrood request Ministerial approval to borrow 217,517.30 from the Royal Bank for a term of 5 years/10-year amortization at a rate of 5.1% with a payment of 2318.08 per month. These monies is to cover the remaining cost of the fire rescue vehicle costing 317,517.30 with a 100,000.00 contribution received from the provincial government.
- **d. BE IT RESOLVED** the Town borrow 217,517.30 from the Royal Bank for a term of 5 years/10 year amortization at a rate of 5.1% with a

repayment of 2318.08 to cover the town's cost of the new fire rescue vehicle.
