6. RECREATION AND COMMUNITY EVENTS

a. Update by Councillor Tilley. Committee met on May 22. Camp A'Hoy registration went well, some weeks have openings, with a limit of 60 kids. Soccer registration has come to a close with 98 kids registered.

Hats of to Tim Hortons for supporting our program for kids 8 and under with jerseys, etc. All the beds in the community garden are rented for the year. Squid Fest details are still being worked out and a full schedule will be put out by the end of June. Interviews for students are taking place this week and next week.

7. INFRASTRUCTURE AND PUBLIC WORKS

a. Update by Councillor Winsor. Committee met on May 16.

Main Beach Lift Station- will submit a gas tax application for a new pump. We talked about a number of RFQ's. Garden Road paving- RFQ went out on May 17. Culver RFQ were due back on May 24. Kiley's Land upgrades- agreed to move forward with RFQ. Street sweeping commenced on May 21. Wood cutting at the soccer field- time for that to get cleaned up and residents will have opportunity to participate in the wood cutting lottery. Hazeldale paving was approved under gas tax funding.

BE IT RESOLVED the Town of Holyrood accepts the recommendation of Department of Transportation & Infrastructure and award the Prime Consultant Services for the feasibility and concept design of the proposed community center to Lean Architects.

There was a limited call for proposals issued by the Department of Transportation & Infrastructure to six companies who are identified on their list of companies with the expertise for this piece of work. Proposals were sent to the department who reviewed and selected Lean Architects as the successful bidder.

Once the contract is signed, the work of determining feasibility and design will begin.

8. PUBLIC SAFETY

a. Update by Councillor B. King and Tilley. Committee met on May 14.

Speed Bump Placement- speeding on town roads are an issue and we will be putting them out soon. If you feel like your street needs to be looked at in terms of speeding, bring forward to the town and we will see what we can do. There are a limited number of speed bumps. Public works will review and prioritize which streets are most vulnerable.

ATV's/Dirt Bikes- Lots of complaining on social media, one complaint was brought to the CAO. Concerns should be put in writing and forward to the town. Then the town can forward those complaints to the RCMP. If complaints come in then the town can ask RCMP to increase their presence in the troubled areas.

The amount of ATV's in the area have increased and is a huge tourist attraction. 99.9% are being respectful.

Junior Firefighter program is well under way, and we hope to start the program in September.

The amount of traffic gathering on the boardwalk due to the whale. Please watch out for kids, dogs, pedestrians, etc.

9. CORPORATE SERVICES & ADMINISTRATION

a. Update by Councillor B. King. Committee met on May 23.

Financial update- Residential tax payments received are at 68%. Water & sewer tax payments received is 60%. Business tax payments received is 73% and Fire Service fees received is 90%.

2025 Assessment will be in the mail by June 3. The town has nothing to do with the assessment, it's an independent agency. If you are not happy with your assessment, contact the Municipal Assessment Agency (MAA). There is a process and deadline to appeal. MAA has a course that you can take (3 modules that take about 20-30 mins each) to get an understanding of how the MAA works and how it is independent.

b. Code of Conduct

On May 4, 2024 the CAO received a complaint under the Code of Conduct. A report was prepared and presented to Council as file COC # 2024-001 for their review and consideration at a privileged meeting on May 14, 2024. Council recommended the complaint be dismissed.
