COR CERTIFICATION

to Be Produced before the Award

The NLSCA administers the COR program to help ensure OHS standardization for the province's construction companies. Until recently there have been three categories within the NLCSA's COR program. A company could have received a Letter of Good Standing stating *In Process*, *Audit Pending*, or *Certificate of Recognition*.

Tenders for contracts that would typically have a COR requirement must use the following language:

*The Contractor shall within 14 days of award of the contract, and prior to commencement of the work, provide a Letter of Good Standing stating Certificate of Recognition (COR) certified from the Newfoundland and Labrador Construction Safety Association (NLCSA)."*

**2. Marina Shores:**

Harbourview Drive includes sidewalks and 4-way intersection

3. Salmonier Line and Route 60 intersection.

4. Municipal Building parking lot on Salmonier Line.

5. Intersection of North Side Road and Route 60 near the main beach

6. Swim Park Asphalt Parking lot Liam Hickey Drive

7. Playground parking lot on Kennedy's Lane Extension off Salmonier Line

8. Roundabout asphalt and sidewalks including colored cement and sidewalk on Maher's River Bridge.

9. Main Beach Park Lot

10. War Monument by the Star of the sea

11. Beaumont Place both sides from Route 60 to the turning bubble.

All culverts/catch basins must be free and clear of any obstruction once Street Sweeping is complete.

Contractor responsible for the disposal of all materials removed.

Contractor will leave all areas in a clean, tidy condition once the paving has been complete.

Contractor responsible for damages to Town owned Infrastructure.

Any change in the contract will be dealt with through “change orders” generated by the contractor and approved by the Town of Holyrood.

**The Town reserves the right to change the unite quantities in any area as the project may determine. The Town may spend less than the total contract dollar amount as to meet Town of Holyrood budget allotments.**

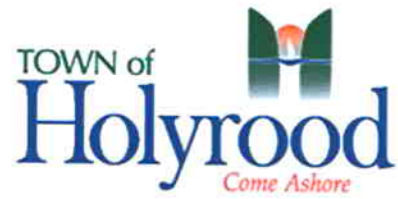
